WHEREAS, pursuant to Administrative Order No. 09-30, the **HONORABLE SHELLEY J. KRAVITZ** was designated to serve as Chairperson of the Canvassing Board; however, she is unavailable to serve; and

WHEREAS, the **HONORABLE NURIA SAENZ**, is available to serve in her stead;

NOW, THEREFORE, pursuant to the authority vested in me as Chief Judge of the Eleventh Judicial Circuit of Florida, Judge Nuria Saenz is hereby designated to serve as Chairperson of the Canvassing Board of Miami-Dade County, Florida on September 16, 2009 for the Special Taxing District Elections and any subsequent meetings pertaining to said elections.

In such capacity, Judge Saenz is hereby authorized to sign all documents pertaining to said election or as required or as authorized by law.
