**IN RE: DESIGNATION OF COUNTY
COURT JUDGE SHELLEY J. KRAVITZ
AS CHAIRPERSON AND CIRCUIT
COURT JUDGE PETER LOPEZ AS THE
MIAMI BEACH RESIDENT APPOINTEE
OF THE CANVASSING BOARD OF
MIAMI BEACH, FLORIDA FOR THE 2009
GENERAL AND RUN-OFF ELECTIONS
AND SPECIAL ELECTION**

WHEREAS, pursuant to Section 102.141, Florida Statutes, a county court judge shall act as the chairperson of the Miami Beach, Florida Canvassing Board for elections; and

WHEREAS, the **HONORABLE SHELLEY J. KRAVITZ** has previously served in such capacity and is available to serve as Chairperson for the upcoming elections; and

WHEREAS, such Canvassing Board must also include an elector who is a Miami Beach resident; and

WHEREAS, the **HONORABLE PETER LOPEZ** has agreed to serve in such capacity; and

WHEREAS, the Canvassing Board will convene on November 3, 2009, and for any subsequent meetings relative thereto, in connection with the Miami Beach General Election for the purposes of electing a Mayor and three City Commissioners and its Special Election for the purpose of presenting to the voters four ballot questions; and

WHEREAS, in the event no candidate for each of the elected offices does not receive a majority of the votes cast in the November 3, 2009 General Election, the Canvassing Board will convene on November 17, 2009, and for any subsequent meetings relative thereto, for the Run-Off Election.

NOW, THEREFORE, pursuant to the authority vested in me as Chief Judge of the Eleventh Judicial Circuit of Florida:

1. Judge Shelley J. Kravitz is hereby designated to serve as Chairperson of the Miami Beach, Florida Canvassing Board ("Canvassing Board") on November 3, 2009 for the General Election for the purposes of electing a Mayor and three City Commissioners and

its Special Election for the purpose of presenting to the voters four ballot questions.

2. Judge Peter Lopez is hereby designated to serve on the Canvassing Board as the elector who is a Miami Beach resident.
3. Should there be a Run-Off Election on November 17, 2009, Judge Kravitz and Judge Lopez will continue to serve on the Canvassing Board in their respective capacities.
4. In such capacities, Judge Kravitz and Judge Lopez will attend all meetings convened for the Canvassing Board and are hereby authorized to sign all documents pertaining to said Election(s) as required or as authorized by law.
